Chief of Staff Fox gave an overview of the updated website.

- Since 2021, Mayor Simmons has appointed eighty-two residents to Boards and Commissions.
- There are 73,447 registered voters in Stamford.
- The application process for Boards and Commissions has been digitized and streamlined.
- The new page features:
 - Thumbnails for:
 - View Boards and Commissions.
 - Apply to a Board or Commission.
 - View downloadable Boards and Commissions report.
 - A City of Stamford Boards and Commissions break down:
 - Gender.
 - Party affiliation.
 - Ethnicity.
 - Tabs for information on:
 - Boards.
 - Members.
 - Vacancies.

The Reps. discussed the updated web page and offered feedback.

2. A31.124 REVIEW; Establishing the Order in which Expirations and Vacancies are Filled on Boards and Commissions.

Attorney Lee provided information regarding expirations and vacancies.

- There is no state law that requires the Appointments Committee to fill one seat before another.
- An ordinance can be created establishing the order of appointments.

Rep. Stella suggested an order for filling expirations and vacancies:

- Expired who have been voted out.
- Expired.
- Vacant.

Information that is subject to disclosure under the Freedom of Information Act:

- Names.
- Addresses and phone numbers.
- Religious and political affiliations.

The public information is available without redaction unless there is an exception that applies such as:

 Personnel records where the disclosure is not a legitimate matter of public concern or considered highly offensive.

Attorney Lee will draft a memo explaining the laws regarding disclosing public information. Chair Patterson adjourned the meeting at 7:42 p.m.
