  the proposed resolution; the Committee can ask Corporation Counsel about any
  legal issues with this inclusion
- Would constituents be deluged with information from all elected officials or should this be limited to Board of Representatives members

A motion to amend the Whereas Clause to delete "and its constituent departments and boards" was made, seconded and approved by a vote of 5-0-0 (Reps. Lion, Matherne, Nabel, Sherwood and Zelinsky in favor).

A motion to amend Paragraph 1 to add "collection and" prior to "maintenance" was made, seconded and approved by a vote of 5-0-0 (Reps. Lion, Matherne, Nabel, Sherwood and Zelinsky in favor).

A motion to amend Paragraph 5 to change "shall" in the first line to "may" was made, seconded and approved by a vote of 5-0-0 (Reps. Lion, Matherne, Nabel, Sherwood and Zelinsky in favor).

A motion to amend Paragraph 5 to change "shall have the ability" in the third line to "may" was made, seconded and approved by a vote of 5-0-0 (Reps. Lion, Matherne, Nabel, Sherwood and Zelinsky in favor).

A motion to approve the resolution, as amended. was made and seconded and approved by a vote of 5-0-0 (Reps. Lion, Matherne, Nabel, Sherwood and Zelinsky in favor).

Committee members continued to discuss this item and whether or not to delete the references to residents on the floor at the Board meeting. The remaining members of the Committee did not think this item should be considered at the full Board meeting and that it should be returned to the Committee for the following month.
