Dr. Fernandes, Dr. Lucero and Mr. Meyer each reviewed various components of the existing policies, together with information about on-going review of the policies. The State of Connecticut has passed legislation regarding the definition of "chronic absenteeism" and the implications for students so identified. Student absenteeism has been and continues to be part of each school's School Improvement Plan which is reviewed and updated each year. An Alliance Grant has been received by the H District and will be used to hire two Social Workers to work on attendance at two schools in the District. The regulations for the attendance policy are in the review process. The most important component to be worked on is the WHY? issue for student absences.

Mr. Casolo gave a summary of the status, planning and projections for the 200 Strawberry Hill property. The project is going well and the financial projections appear to be on target.
