

Economic Development

Program/Mission

- To provide rich business resources for the creation, growth and recruitment of companies, new business, organizations and real estate development to the City;
- Promote the expansion of existing industry by providing assistance to businesses seeking to improve or expand their scope of business activity in Stamford;
- Retention of existing business by assisting small and large businesses, as well as supporting women, veteran and minority-owned businesses; promote tourism within the City; and
- Be the point of coordination for new businesses considering Stamford and oversee inter-government relations and management of the City's federal and State lobbying services.




Economic Development

Major Projects:

1. Company Outreach and Relocation

- Meet with six companies about relocating to Stamford.
 - Deutsch Family Wine & Spirits (100 people) and Serendipity Labs (30 people) are moving to Stamford;
 - Two additional companies (100 People) are in the final phases of the decision making process.

2. "Job Growth and Business Retention Program"

 Collaborating with Daymon Worldwide and Stamford Partnership on the project



Major Projects:

- 3. Stamford's Small Business Portal
 - Cooperation with Mayor's Youth Employment Program and Economic Development intern program
 - Employed seven interns to research and design the site
 - By using interns to develop the site the city saved over \$200,000
- 4. Energy Improvement District Energy and Resiliency Upgrades to City Buildings
 - Supervising service contractor (Con Edison Solutions), currently reviewing the 60% feasibility study.
 - Project will potentially lead to extensive energy improvements with possible savings of over \$1 Million per year;
 - \$100,000-\$200,000 in positive cash flow for the City.



Major Projects:

- 5. Stamford Economic Development Plan
 - Initiated plan as recommended by Stamford Master plan
 - Four focus areas Infrastructure, Business Development, Work Force Development, Arts, Culture and Tourism
- 6. Statewide Gigabit Fiber Project
 - Continued to work with State on the next steps of the project
 - Developing a Feasibility Study to explore costs of project
 - SB331- An Act Establishing A High-Speed Internet Service Pilot Program





On Going:

- Executive Briefings with Mayor and largest company CEO's in Stamford
- "Rapid Approval Process" for critical projects (e.g. the "Hole in the Ground.")
- Ongoing monitoring of critical bills affecting the city and testified before the legislature on those having major impact on the city's economy
- Partnered with the Business Council of Fairfield on the 2030 district that will help with marketability of Stamford.



2016-2017 Goals

1. Economic Development Plan

- Target completion date Fall 2016
 - The plan involves working with the Steering Committee and four subcommittees.
 - Big Tent approach to working with the different groups within City
 - Study is being preformed in-house to save money (\$200,000)

 - Working with Mayor's Youth Employment program and Economic Development Intern Program (15 Students)
 - Work to be preformed in-house to save money (\$150,000)
 - Project Expected Completion Fall 2016





 - # of Stamford workers under age of 29












Stamford Workforce


- Stamford has outpaced Connecticut in population growth in the past 5 years

Stamford Population


Workforce: Median Age


- Median age decline contradicts shift towards an older demographic that the state has been experiencing

Companies coming to Stamford

- Bridgewater Associates, one Connecticut's largest hedge funds, will move approximately 300-400 workers into 137,000 sq. ft. of commercial space in one of the office buildings at Harbor Point.
- Rhone Apparel recently bought 482 Pacific Street building; bringing 25 new employees to Stamford with expectations to grow by another 100 employees over the next year.
- Deutsch Family Wine & Spirits moved it's headquarters to Stamford from Westchester County and taking a long term lease for 45,000 sq. ft. at the Purdue Building for its 100 employees.
- Serendipity Labs is opening a co-working location at 700 Canal Street bring 30 people.
- Yale-New Haven Hospital took a lease for 50,000 sq. ft. office space at 260 Long Ridge Road

Companies Expanding in Stamford

- Indeed.com has taken a lease for an additional 100,000 sq. ft. of office space at their 177 Broad Street location. Indeed.com expects to have 750 employees by years end.
- Tagetik North America LLC, provider of global performance management software has opened its new North American headquarters at 9 W Broad St. in order accommodate significant growth in the number of employees
- NBC Sports continues to expand in Stamford after completing its \$100 million state-of-the-art 300,000 square foot facility, and employs initially nearly 600 people. NBC Sports has relocated its NBC Deportes production unit would migrate its operations from Telemundo's headquarters in Hialeah, Florida to Stamford bring with it another 100 jobs.
- Stamford Hospital continues to expand in the city taking 46,000-squarefoot building at 292 Long Ridge Road, the hospital is expecting 25 doctors and 50 support staff to be located here




UCONN Stamford

- Building 200-300 beds of student housing in the downtown area
- Selecting for eleven proposals
- Expect a decision on final site by spring 2016

Infrastructure: Housing Units

- The total number of units has generally increased from 2000 to 2014
 - Small dip attributable to economic recession
- Despite increase in number of housing units from 2012-2014, there was no change in:
 - Number of rooms per housing unit
 - Average size of the housing unit




Total housing units

Infrastructure: Housing Units

- Waterside/South End was the quickest growing neighborhood between 2000-2010
 - 28.5% increase in housing supply
 - Apartments/condos were built
- Areas with the most units as of 2010:
 - Glenbrook 5,444
 - North Stamford 5,289
- Extensive growth in Waterside/South End since 2010

Housing Supply Increase By Neighborhood ⁽²⁰⁰⁰⁻²⁰¹⁰⁾





In Progress:

- Belpointe, 112 Southfield Avenue 109 multi-family residential apartments overlooking the west branch of the Harbor
- Rippowam Place on Washington Boulevard, 118 dwelling units, 1,500 square feet of ground floor retail, 4,200 square feet of restaurant space overlooking Stamford's Columbus Park.
- Bedford Hall, 545 Bedford Street, 82 residential units
- Marriott Residence Inn Seaboard Properties Stamford's first extended stay hotel, 131 rooms
