Stamford Center for the Arts Budget Presentation FY2016-2017 City of Stamford

Mission and Goal Statement:

The mission of Stamford Center for the Arts (SCA) is to: (i) present the premier performing arts and cultural performances in Fairfield County, (ii) entertain, engage and enlighten our audiences of all ages, (iii) enrich the cultural, educational, economic and social life of the community, (iv) foster and promote diversity of thought, ideas, and culture and (v) nurture appreciation of the arts in children, teens and adults through our arts education programs. SCA's vision is to support, promote and host a variety of performing arts, education and outreach programs to diverse audiences in Stamford and in the greater Fairfield County region. The Palace Theatre is also home to the Ballet School of Stamford, Connecticut Ballet, Namaskaar Foundation, Lumina String Quartet, Stamford Symphony and the Stamford Young Artists Philharmonic. SCA enriches Fairfield County and its diverse cultural heritage by developing and supporting works of artistic excellence, advancing learning in the arts, strengthening arts in the community, and contributing to the area's economic development.

Main Goals and Objectives of FY 2016-2017:

1. Provide economic stimulus to the area by offering world class entertainment, valuable education, and cultural enrichment programs for our community.

The attached 2016-2017 budget for Stamford Center for the Arts reflects the immediate plan for the organization. SCA continues to achieve growth and stability by minimizing risk in presenting and producing, and maximizing revenues through entrepreneurial relationships with promoters with an emphasis on enhanced earned income. In combination with continued support from corporate sponsors and individual donors, the 2016-2017 Budget will allow SCA to remain loyal to its mission to foster the arts in the community. SCA will continue its existing relationships with resident arts partners to collaborate and cooperate in creating a culturally vibrant destination here in Stamford.

2. Expand arts education programs to allow additional opportunities for participation.

In the past year, SCA has presented many education programs including Young Choreographers Festival, Next Generation and the Young Playwrights Festival. Our Summer Program had two arts camps: Triple Threat Performer Intensive and Circus Week. SCA is expanding it's summer educational camps to 5 programs.

3. Diversify and offer increased programming to bolster attendance.

SCA is currently presenting programming in the areas of education and special events in this area. SCA is also working collaboratively with its residents in producing programs at The Palace for the community, including a new family programming series called Playtime at The Palace (currently in it's third season); Jazz Alley, hip and mellow groove of unique music; LaughTrax, a comedy series featuring a diverse offering of various styles; and the Songbook Series featuring world class cabaret performers.

Last year, SCA presented Young Choreographers Festival; The National Circus Project; Jeff Dunham; Chicago City Limits; Amy Grant; Haunted Illusions; Michael Feinstein; The Four Freshman; It's A Wonderful Life, The Radio Play; Gabriel Iglesias; and Mannheim Steamroller, STOMP, Sid the Science Kid, Men are from Mars-Woman are from Venus, Tony DeSare, Cyrille Aimee, Jim Henson's: Dinosaur Train LIVE, The Hit Men and Jay Leno. This year SCA has already presented the following shows: Alexis Cole, Angelo Lozada, Mark Twain Tonight, The Wiggles, Steve Ross, Disney's Beauty & The Beast, T. Oliver Reid, Bill Engvall, The Ben Allison Group, One Man Star Wars Trilogy, The Brian Setzer Orchestra, Rudolph, Pizzarelli, A Christmas Carol and Sons of Serendip. In addition, we will be presenting 42nd Street, Casey Carle's Bubblemania, John DiMartino, Ladies of Laughter, Uptown Showdown, Lynn Trefzger, Chicago City Limits, Jungle Jack Hanna, Wild Kratts, Silient Slapstick, Moon Mouse, National Geographic Live, Phenomenal Physics with Mr. Fish, Sesame Street Live, Big Daddy Weave and Daniel Tigers Neighborhood. SCA is planning an initiative involving marketing and development to increase audiences and collaborate with local businesses for mutual benefit.

4. Continue SCA's reinvestment in our physical plant.

With City assistance, the roof of The Palace was replaced and new coping installed. We are in the process of completing repairs to the north wall in order to seal the structure from water leaks. In addition a safety project was initiated to stabilize failing plaster in the auditorium. The Palace also purchased a new high capacity ice machine to replace the previous 12 year old machine.

Stamford Center for the Arts Budget Presentation, FY2016-2017 City of Stamford

Budget Narrative:

For FY 2016-17, SCA is requesting \$20,000 in funding from the City to apply directly to keeping our lights on. We would use this entire allotment to put towards SCA's utility bills.

The budget for FY17 reflects the continuation of the business plan for SCA. This is predicated on expanding SCA's community-oriented programming achieved in partnership with artists and other arts organizations.

The building usage is reflected in the budget under rental income and programming revenues. This usage is reflected by shows brought by outside promoters, arts partners, and community organizations and corporations renting the theatre and its related spaces. The usage will also result in box office service revenues and concession sales. The programming revenue reflects shows presented by SCA with plans for the next fiscal year to continue to present shows.
