## **Committee Budget Meeting Report**

Date:Saturday, April 24, 2021Time:9:00 a.m.Place:Meeting was held Remotely.

The Fiscal Committee met as indicated above to review the Fiscal Year 2021-22 budget. In attendance were Chair Di Costanzo, Vice Chair Miller and Committee Member Reps. Coleman Fedeli, Figueroa, Morson, Nabel, and Pendell. Rep. McMullen was excused. Also present were Reps. Curtis, de la Cruz, Lion, Matherne, Stella, and Summerville; Jay Fountain, Anthony Romano and Adrianne Tovar, OPM; Sandra Dennies, Director of Administration; Dr. Tamu Lucero and Ryan Fealey, Stamford Public Schools.

Chair Di Costanzo called the meeting to order at 9:15 a.m.

<sup>1</sup>The Committee first considered the Board of Education Budget. Committee members discussed the proposed use of the ARP funds with the invited guests. The expectation is that SPS will receive \$37 million, but there has been no confirmation of this figure. None of these funds will be spent on Operations. 20% will be spent, as required by the program, on learning loss. It is possible that some of the funds will be spent on HVAC/air quality. It will be clear that any additional positions to address learning loss will be limited to a 2-3 year period. The district may also choose to use outside consultants.
