**WHEREAS**, the City of Stamford has applied for and received a grant award for financial assistance from CT Division of Emergency Management and Homeland Security for the Region 1 EMPG Pool project supporting all-hazards emergency management missions' areas for the region; and

**WHEREAS**, the City of Stamford approved the appropriation for this project at a regular meeting of its Board of Representatives on August 5, 2024;
