**WHEREAS**, the City of Stamford has applied for and received a grant award for financial assistance from the State of Connecticut Department of Emergency Services and Public Protection for an Auto Theft Task Force project; and

**WHEREAS**, the City of Stamford approved the appropriation for this project at a regular meeting of its Board of Representatives on October 7, 2024; and

**AND BE IT CERTIFIED** that Caroline Simmons was elected Mayor, that her term of office began on December 1, 2021 and will continue until November 30, 2025, and that, as the Mayor, Caroline Simmons serves as the Chief Executive Officer for the City of Stamford and on October 7, 2024, has both the authority and the office to enter into agreements on behalf of the City of Stamford.
