RESOLUTION NO. 4411 AUTHORIZING THE MAYOR TO ENTER INTO AND SIGN AGREEMENTS WITH SHINE EARLY LEARNING, INC. FOR SCHOOL READINESS PROGRAMS

I, David Hoak, do hereby certify that I am the City and Town Clerk of the City of Stamford, a municipal corporation organized and existing under the laws of the State of Connecticut having its principal place of business at 888 Washington Boulevard Stamford, Connecticut, and that I am the keeper of the corporate records and seal. I also certify that the following is a true and correct copy of a resolution duly adopted and ratified by the Board of Representatives of the City of Stamford on January 5, 2026 in accordance with the constituent charter of the City of Stamford and that the same has not in any way been modified, repealed or rescinded, but is in full force and effect.

BE IT RESOLVED, that Caroline Simmons, Mayor of the City of Stamford, may enter into an agreement with and deliver to Shine Early Learning Inc , on behalf of the City of Stamford, all documents which it deems to be necessary or appropriate related to support School Readiness programs.

NOW, THEREFORE, BE IT RESOLVED that Caroline Simmons, as Mayor of the City of Stamford, is authorized and directed to enter into, execute and deliver any and all agreements and ancillary documents on behalf of the City of Stamford and to do and perform all acts and things which she deems necessary or appropriate to carry out the terms of said grant and such agreements.

AND BE IT CERTIFIED that Caroline Simmons was elected Mayor, that her term of office began on December 1, 2025 and will continue until November 30, 2029, and that, as the Mayor, Caroline Simmons serves as the Chief Executive Officer for the City of Stamford and on January 5, 2026, has both the authority and the office to enter into agreements on behalf of the City of Stamford and to sign on behalf of the City of Stamford for financial assistance for the support of the School Readiness programs
