## RESOLUTION NO. 4416 AUTHORIZING THE MAYOR TO ENTER INTO AND SIGN AGREEMENTS WITH THE CT DEPARTMENT OF TRANSPORTATION FOR 2025-26 ACTIVE TRANSPORTATION MICROGRANT PROGRAM
