## RESOLUTION NO. 4420 AUTHORIZING THE MAYOR TO ENTER INTO AND SIGN AGREEMENTS WITH THE U.S. DEPARTMENT OF JUSTICE FOR COPS HIRING PROGRAM

**AND BE IT CERTIFIED** that Caroline Simmons was elected Mayor, that her term of office began on December 1, 2025 and will continue until November 30, 2029, and that, as the Mayor, Caroline Simmons serves as the Chief Executive Officer for the City of Stamford and on February 2, 2026, has both the authority and the office to enter into agreements on behalf of the City of Stamford.
