Ms. Cammarota explained that this grant provides funds for time periods designated by the State in April and August for distracted driving enforcement. The amount contributed by the City, \$16,667, is 25% of the total program, not 25% of the grant. A motion to approve this item was made, seconded and approved by a vote of 7-0-0 (Reps.

Mr. Handler explained that the purpose of this appropriation is to get pre-planning work done before the next fiscal year. Mr. Casolo explained that he and his office are intimately involved in this process and it will allow the project to begin moving forward. They are hiring an architect. This is a complicated project because it involves 3 parcels, and they need to perform appraisal services and a Phase 1 environmental analysis. His office is administering the entire project. The cost estimate is based upon his discussions with the architects regarding the work to be done. In addition, pragmatic work for the Police Department needs to be done – how it should be designed and how it should be phased to allow the department to continue working. In response to questions from the Committee, he noted that

- It is good practice to do a Phase I assessment for the parcel the City doesn't own
- This was the most feasible of all the sites the City considered
- He has written an RFQ for engineers with experience with Police Departments;
 They had 9 submissions and will interview 5.
- They looked at other sites, expanding the current site, remediation and using substations (the department felt this would decrease their effectiveness)

A motion to approve this item was made, seconded and approved by a vote of 6-0-2 (Reps. Fountain, Coleman, Day, DeLuca, Mitchell and Silver in favor; Reps. Cerasoli and Figueroa abstaining.)

A motion to suspend the rules to take up this item was made, seconded and approved by a vote of 9-0-0 (Reps. Fountain, Cerasoli, Coleman, Day, DeLuca, Fedeli, Figueroa, Mitchell and Silver in favor.) Mr. Pollard explained that the City was approached in December, 2013 by Trinity to alert them that by February, 2014, the repayments of funds deposited with the URC would be triggered. He met with the URC, but the URC was unable to deliver the funds to Trinity. The City worked with the URC to reach an agreement. The URC was able to fund \$100,000 of the amount and the City would pay the balance in a fully secured loan. The City had Blum Shapiro conduct an audit of the

URC's assets and cash flow to ensure that the loan would be paid back. Committee members expressed concerns about the inability of the URC to return the deposit due to Trinity, and suggested that an audit be conducted to determine what happened to the funds. Ms. Cooper stated that she is satisfied as to the priority of the City's lien in the event of a default. She supervised the work by outside counsel. A motion to approve this item was made, second and approved by a vote of 10-0-0 (Reps. Fountain, Cerasoli, Coleman, Day, DeLuca, Di Costanzo, Fedeli, Figueroa, Mitchell and Silver in favor.)
