Ms Cammarota explained that these are State grant funds to be used for capital technology expenses. Mr. Pensiero stated that the monitors in the communications Center are reaching the end of their useful life. This grant will provide a 50% reimbursement for the cost of the replacement. If the old monitors cannot be used, they will be recycled responsible. The purchase will be made from an existing account.
