January, but the City felt it was late and requested and received permission from the State that anyone who applied and was approved in July will automatically be approved this time and will continue to accept new applicants. The rules of the state are, if you are not changing your program there is no vote required from the legislative body and the City of Stamford is not changing, just extending the program.
