The funds are used for equipment purchases, training, the bomb squad, cyber security funds, ppe, barricades, etc. The city receives \$50,000 to serve as a fiduciary for the region. Ms. Drew explained that there has been a huge uptick in opioid use and fentanyl, and the funds will be used to begin prevention initiatives for the city. Ms. Dennies explained that the Board of Ed accountant position is being requested because the BOE is putting forth a long-term facilities plan which touches every single building in their system, and addresses all of the issues related to those buildings - systems, envelope, replacement, new construction and renovate as new. The costs for that program are exceptionally high. This accountant position will focus on the long-term facilities and will ensure that grant applications and materials are submitted to the State to provide for maximum reimbursement, and that the reimbursement is monitored. Anything that is grant funded can't be bonded. In addition, the Board of Ed also has other sources of Grant funds that will be used for the Long Term Facilities plan. This appropriation represents the salary for the December 1st through June 30th timeframe.

In response to questions from the Committee, Ms. Dennies and Mr. Yanik explained that this will be a union position with all benefits. The LTF plan is a 20-year plan, so it is better to have a municipal employee than hire a contractor. BOE transactions are processed through the City, so this appropriation is also processed through the City. The position will be included in next year's budget at about \$130,000. It will be difficult to find an accountant with municipal and grants experience. In order to receive reimbursement, you need to know what you can submit for reimbursement and monitor the reimbursement to make certain that they are reimbursing the same way that you have, in fact, submitted them. The six-month period after the completion of the project is the window that the State normally has to audit the project, but the State doesn't have a huge team of auditors. In some of the past the City has had to wait for auditors to be assigned to be reimbursed, now the City can hire independent auditors who can evaluate the reimbursement rates.

Mr. Petise explained that the City received 5 bids, all of which were above the previously approved amount. All were within 4%, and were high due to the increase in prices. The contract also includes amounts for contingencies and incidentals. This is 100% state funded. The work will probably begin in the spring. The total project cost is \$3.19 million. Assistant Chief Robles explained that the planning to purchase a new truck began more than one year ago. At that time, they thought that \$1.7 million would be sufficient, but prices have increased and they have been told that more increases are coming. This will replace the current truck in the South End, which is from 2006. Trucks should be replaced every 15 years and will take 2 years to receive this truck. The department is concerned that the current truck may not last that long, in which case they will have to borrow a truck. They received a quote for \$1.829 million in July, so this appropriation should cover the entire cost. A motion to approve Item No. 14 was made, seconded, and approved by unanimous voice vote (Reps. Assistant Chief Robles explained that this is the oldest fire station and only has a male bathroom. The goal is to have 2 bathrooms. The original plan was to spend \$200,000, but bids came in at \$300,000. The City engineer was asked to reconfigure the plans to reduce the costs. It was sent out to bid again, and, came back at just under \$300,000 due to recent price increases. The project was broken down into separate parts. The cost of the required asbestos abatement will come from another fund. This will require replacement of the plumbing to the street and moving of a wall of the gym, replacing the acoustic tiling, LED lighting and removing the carpeting to avoid contamination.
