CORRECTION Annual Action Plan for HUD Entitlement funds

The proposed 2021-2022 Annual Action Plan (AAP) for the use of federal housing and community development funds by the City of Stamford (City) is available for public review and comment. The U.S. Department of Housing and Urban Development (HUD) has not notified the City how much it will receive from the Community Development Block Grant (CDBG) or from the HOME Investment Partnerships Program (HOME). The plan has been developed based on an estimated CDBG allocation of \$970,410 and \$439,578 HOME allocation. In addition, there is a projected HOME/CDBG housing loan program income of \$50,000 that will be used for housing rehabilitation and downpayment loans.

HUD funds are intended to principally benefit low income persons in Stamford by providing decent housing, a suitable living environment and expanding economic opportunities. The proposed AAP will fund programs and projects that provide affordable housing, revitalize neighborhoods, fight poverty, improve homeless shelters & daycare, promote job growth and provide support services related to youth, elderly, health and homelessness.

The proposed AAP provides \$145,562 for public services for the hungry, homeless, youth, elderly, and victims of domestic violence; \$427,606 for improvements to facilities including a daycare center, health center, homeless shelter, community center, and a rehab facility; \$203,160 in CDBG funds and \$325,683 in HOME funds for affordable housing, and \$194,082 for grant administration. If the CDBG allocation is less than estimated funded public service activities will be decreased pro rata from the estimated funding allocation to match the actual allocation amount; no funded public service activity will receive less than \$5,000. For the balance of activities (public improvements and housing) a decrease in funding will first be applied to the contingency line. If further reductions are necessary pro rata reductions will be made to all Program Income and Housing programs. If necessary funds for grant administration will be decreased from the estimated funding levels to match the actual allocation amounts. HOME will be increased or decreased from the estimate funding levels to match actual allocation amounts.

The Citizen Participation Plan, the Year 47 Consolidated Annual Performance and Evaluation Report (CAPER), the 2020-2024 Consolidated Plan and HUD's review of the CAPER are available for review online at www.stamfordct.gov. On Monday, March 15, 2021 at 6:30 p.m. virtually, the Housing, Community Development and Social Services (HCD/SS) Committee of the Board of Representatives will hold a public meeting to accept verbal or written comments from citizens regarding the proposed AAP. In response to public comments the Mayor and HCD/SS Committee will finalize the AAP.
