PUBLIC HEARING NOTICE CITY OF STAMFORD BOARD OF REPRESENTATIVES



Notice is hereby given that the Land Use/Urban Redevelopment Committee of the Board of Representatives of the City of Stamford will hold public hearings on Wednesday, February 1 at 7:00 p.m. in the Republican Caucus Room, 4th Floor, Government Center, 888 Washington Boulevard, Stamford, CT to consider the following proposed ordinances approved for publication at the December 5, 2016 Regular Board Meeting. SUMMARY OF PROPOSED ORDINANCE RESTRUCTURING THE URBAN REDEVELOPMENT COMMISSION

This ordinance amends Chapter 6, Authorities, Board and Commissions, Article IV, Urban Redevelopment Commission, to 1) permit the Mayor to appoint members of the Economic Development Commission ("EDC") to serve as members of the Urban Redevelopment Commission ("URC"), and have the Director of Economic Development, to the extent possible, serve as the Executive Director of the URC if the members of the EDC are serving as members of the URC; and 2) to require the URC to consult with the Office of the Mayor and an attorney from the Office of the Corporation Counsel prior to any proposed transaction, redevelopment activity or amendment to existing commitment, in order to ensure it is in the mutual best interests of the City and URC.

SUMMARY OF PROPOSED ORDINANCE AMENDING SECTION 88, BUILDINGS, DEMOLITION OF

This ordinance amends Chapter 88, Buildings, Demolition of, Section 88-5, to conform to Public Act 16-09, and prohibits individuals seeking demolition permits from taking any action toward demolition, during the waiting period set forth in Section 88-5, unless the Chief Building Official determines that a danger to public health will result.
