**SUMMARY OF PROPOSED ORDINANCE PRESCRIBING  
THE ENGAGEMENT OF EXPERTS BY THE LAND USE BUREAU  
CHIEF OR THE LAND USE BOARDS**

This ordinance amends Chapter 123, Fees, Article VII, Application Fees, to permit the Land Use Boards of the City of Stamford to retain the services of one or more independent experts in reviewing applications, either upon the determination of the Land Use Bureau Chief or the Boards, and to allow the Land Use Bureau Chief or the Boards to assess and collect 125% of the reasonable cost of such expert or experts from the applicant, to be held in escrow until the completion of the technical review. Any excess amount collected over the actual cost shall be returned to the applicant. The failure to pay such cost within 5 days of notice of the assessment will render an application incomplete.

Pursuant to Sections C1-50-3 and C6-120-3 of the Stamford Charter and Sections 9-8 and 9-7.3 of the Stamford Code of Ordinances, the Memorandum of Understanding ("MOU") between the City of Stamford ("City") and the Connecticut Department of Transportation ("CTDOT"), dated November 21, 2013, conveying 105 Myrtle Avenue, Stamford, Connecticut from the CTDOT to the City and conveying 133 Myrtle Avenue, Stamford, Connecticut, from the City to the CTDOT in accordance with the terms and conditions set forth in the MOU, which is incorporated herein, is hereby approved; and

The Mayor is hereby authorized to execute any instrument he deems necessary or desirable in connection with the execution of such MOU and/or carrying out the duties and obligations of the City contained therein.

This Resolution shall be effective as of the date of approval.
