We would join in the comments made by the Law Firm of Wofsey Rosen sent to your office on July 6<sup>th</sup> on behalf of members of Sterling Lake Homeowner's Association regarding item LU30.014 on the Land Use-Urban Redevelopment Committee agenda for July 10<sup>th</sup>. We have reviewed the conclusions of the City Attorney's office and find the legal reasoning contained therein flawed, and resulting in the disenfranchisement of a large percentage of Stamford's land owning population. Avoiding an absurd interpretation of the City's Charter so as to deprive property owners the right to petition for redress over zone changes was specifically cautioned against by the Connecticut Supreme Court as far back as 1990.
