

The number one reason that the Planning Board unanimously voted to deny the LTF application was noise and its affect on the neighboring residential communities.


I urge you to please join with the Planing Board and vote to reject the LTF text code change application.

As a resident, member of the Stamford Neighborhoods Coalition, Steering Committee and supporter of the petitioners, I thank the Land Use Committee for their thoughtful, probing and thorough questions at the public hearings for LU30.015 zoning appeal case re: C-D/Mixed-Use Campus Text Change. I have contacted the Committee about my serious concerns regarding the Planning and Zoning Board decisions and trust they will recommend a NO Vote to the full Board. I am now reaching out to you to put the your **Constituents and the Plan first**.

The Planning Board let some of the Master Plan slip away by acknowledging a "gymnasium and physical culture establishment definition", that was open-ended, to be an acceptable use in C-D/Mixed-Use Campuses. Thankfully, they acknowledged "Outside Use" was not acceptable. For sure, in this case, they bent over backward to accommodate the developer and in so doing compromise the integrity of the Master Plan for our City....the protections for residential neighborhoods intended in the Plan were put in jeopardy.

The Zoning Board just let it all slip away by approving this plain vanilla definition that will not allow them to stop an outdoor use that could easily be "sold" by a very effective salesman/lawyer as part of this definition and forever destroy the appearance of these "Parks". The character, property value and quality of daily life of these residential neighborhoods will be changed forever.

I respect the hundreds of hours these board members devote to their work for the City. My observation after attending many of their meetings and public hearings is that the "people" and the "Plan" are ultimately second and third considerations. Both boards have been so conditioned to find ways to support developer applications, that in the end, the Master Plan protections are lost in the desire to approve. In this case, the Planning Board tried to protect by denying the Application with recommendations, but the Zoning Board sold away our residential neighborhoods.

I turn to you, as our elected officials to overturn this text change. Our Planning Board needs to go back to the drawing board and put tighter controls in our zoning regulations. Vote NO on the zoning board request to Reject the petitioners' Appeal.
