Mr. Casolo, Mr. Rosenberg, and Ms. Grafstein explained this item and there was Committee discussion.

- The street is classified as unaccepted and therefore is not on the paving list.
- The City ordinance outlines the process required to gain acceptance.
- Emergency paving can be done through a process of getting homeowners to agree, which the homeowners did in the past, but it was determined that emergency repairs were not warranted.

- Residents recently tried to get potholes filled but could not because it was not an accepted street, and residents have been told the garbage trucks might not come down the street because of the conditions.
- A resolution was passed in 1984 to get Peak Street accepted. There are procedures involved beyond that which include residents paying a percentage of costs involved; it is possible the homeowners decided not to pursue the street acceptance after finding out the costs to them.
- There are over 100 unaccepted streets in Stamford, which means the streets were not made to City standards.
- Are new homeowners aware they are buying a house on an unaccepted street?
- Certain unaccepted streets have maintenance agreements in which homeowners are bound to maintain the streets to some extent.
- Should the BOR start looking into making all streets accepted?
- What is City liability on unaccepted streets?
- Can the process of getting a street accepted be streamlined?
- Peak Street residents agreed in late 2017 to request emergency paving. Ms. Grafstein will look into the potholes being filled as an emergency measure.
