- 1) Amend the Now therefore clause read: Chapter 29, Historic Preservation Trust Fund of the City of Stamford Code of Ordinances be added to the Code of Ordinances as follows:
- 2) Amend section 29-3 as follows:

There shall be seven (7) Trustees on the Board of the Trust, five (5) who shall serve ex officio and two (2) members of the public. The Trustees shall be the Land Use Bureau Chief or such Chief's designee, the President of the Board of Representatives or such Chair's President's designee, the Chair and Vice-Chair of the Historic Preservation Advisory Committee or their designees, the Chair of the Board of Finance or such President's Chair's designee, and two (2) members of the public who are members of the Stamford community who either have historical preservation experience or are the owner(s) of an historic property, who shall be appointed by the Mayor and confirmed by the Board of Representatives, whose terms shall be three years. The Land Use Bureau Chief shall serve as the Chair of the Board of Trustees. No Trustee shall receive a salary or other remuneration for serving on the Board.
