The Land Use-Urban Redevelopment Committee will meet as indicated above. In attendance were Co-Chair Sherwood, Co-Chair Tomas, and Committee Member Reps. Boeger, Cottrell, Fedeli, Figueroa, Goldberg, Miller, Morson, Shaw, Walston, and Weinberg; Ralph Blessing, Land Use Bureau Chief; David Herz, Stamford Neighborhood Coalition Attorney and Barry Michelson, South End Historic District Study Committee. An overview of the proposed text changes and procedures was discussed.

- The signatures of at least 300 landowners shall be required to determine the validity of the petition.
- 309 signatures were valid which represent 0.228% of the residents of Stamford based on the 2020 census numbers.
- Several deletions in section 1.A. were suggested by the Law Department.
- Several guiding principles were also deleted as the Law Department found that the language was more a policy statement and should not be in the purpose section.
- Part of the regulations that were originally deleted has been picked up.
- One of the purposes of the text change in section 1.A. was to align the purpose section of the zoning regulations with the state statute.

A motion to hold Item 1 was made, seconded, and rejected by a vote of 4-5-1 (Reps. Adams, Campbell, de la Cruz, and Mays in favor, Chair Sherwood, Co-Chair Tomas, Reps. Camporeale, Kuczynski, and Matheny not in favor and Rep. Summerville abstained).

Further discussion was had.

A motion to hold Item 1 was made, seconded, and rejected by a vote of 3-4-0 (Reps. Adams, and Camporeale in favor, Chair Sherwood, Co-Chair Tomas, Reps. Matheny and Summerville not in favor).

Further discussion was had.

A motion to hold Item 1 was made, seconded, and approved by a vote of 7-0-0 (Chair Sherwood, Co-Chair Tomas Reps. Adams, Camporeale, de la Cruz, Matheny, and Summerville in favor).

Chair Sherwood adjourned the meeting at 12:23 a.m.
