Thirty-five years ago I sat where you sit now, as a Representative of the First District on Stamford's Board of Representatives. I know that many issues come before the Board, and I also know how you struggle to take into account differing and conflicting viewpoints, and try to do what is best for the City of Stamford that we all love.

I believe that the issue of banning single-use plastic bags is one of the most critical to come before the Board of Reps in recent years. We all have read and heard how damaging plastic is to the environment, especially those items (like bags, straws, etc.) that are only used one time.

I strongly support the plastic ban ordinance, the hybrid model, which requires a charge for the paper bag. Banning plastic bags would serve many important environmental goals at minimum or no cost to the City. Minimizing plastic bag use would help to reduce the use of oil which is required to manufacture the plastic bags; reduce the greenhouse gases generated by their manufacture; and minimize unsightly plastics bags in our trees, on our streets, parks, rivers, and LI Sound. It would also reduce the impact on wildlife, particularly marine animals, some of which mistakenly consume the plastic and sicken and die.

The charge for a paper bag would provide an incentive for consumers to bring their own reusable bags and minimize the number of paper bags being used. Without a charge for paper bags there would be a large increase in paper bag use.
