The best working bag law in the country is arguably, California model. It calls for a reusable bag that is more than 2.25 mils. These 2.25 MIL bags are reusable and comply with single-use bag ban laws in California and Chicago. They feature die cut handles for easy carrying and are made of recyclable material.

Beyond banning single use bags and offering alternative options for takeout, we must make a concerted effort to educate consumers to remember to bring their own reusable bag.

Thank you again for speaking before the L&R committee regarding our proposed ban on plastic bags in Stamford last May. We were hoping you might be able to return to discuss one of the finer points of our review, regarding the thickness of plastic bags which would be exempted from the ban.
