**SUMMARY OF PROPOSED ORDINANCE  
AMENDING §231-8 OF THE CODE OF ORDINANCES REMOVAL OR

This ordinance amends Section 231-8 of the Code of Ordinances to include a late fee of \$25.00, a replacement fee of \$500.00, and a \$500 fine for damage to self-releasing immobilization devices used on vehicles bearing outstanding citations.
