**NOW THEREFORE BE IT RESOLVED BY THE 30TH BOARD OF
REPRESENTATIVES THAT:**

Pursuant to Section C1-50-3 of the Stamford Charter and Section 9-7 of the Stamford Code of Ordinances, the lease ("Lease") between the City of Stamford ("Lessor") and the Stamford Federal Credit Union, Inc. ("Lessee") for office space on the 6th floor of the Stamford Government Center, and space for an ATM machine in the lobby of the Stamford Government Center, in accordance with the terms and conditions set forth in the Lease, commencing upon the date of execution and terminating five years thereafter, with 2 additional five year renewal terms, is hereby approved; and

The Mayor is hereby authorized to execute such Lease and to execute any instrument he deems necessary or desirable in connection with the execution of such Lease.
