I am writing to let you know that Stamford's City Council, the Stamford Board of Representatives, is considering a local ordinance to prohibit the unattended tethering of dogs. If passed, Stamford will become the first municipality in Connecticut, if not New England, to implement such common-sense animal welfare legislation. The language being considered provides:

(4) No person shall tether a dog to a stationary object or to a mobile device:

(a) Unless the owner or keeper is outside with the dog and the dog is in the owner's or keeper's view...

The Committee considering this language is voting this Thursday, June 22, at 7:00 by webinar. Members of the public are encouraged to attend and participate during a public hearing.
