CONCERNING A TAX ABATEMENT AGREEMENT BETWEEN THE

This ordinance grants an abatement of seventy five percent (75%) of all real property taxes assessed by the City on the real property and improvements located at 72 Spruce Street, Stamford, CT, in accordance with the terms of the proposed tax abatement agreement and authorizes the Mayor to act on behalf of the City of Stamford, to execute and deliver all documents they deem necessary or desirable.

This ordinance shall take effect upon enactment.
