## **Committee Report**

The Legislative & Rules Committee met as indicated above. In attendance were Chair Heaphy, Vice Chair Coleman and Committee Member Reps. Day, Mitchell, Nabel, Okun, Ryan, Silver and Zelinsky. Also present were Kathryn Emmett, Corporation Counsel; Jonathan Gottlieb and Vin Tufo, Charter Oak Communities; Sandy Goldstein, John Ruotolo and Cheryl Virkelik, DSSD; Jim Hricay, OPM, and five members of the public (see attached public hearing sign-in sheet).

Chair Heaphy called the meeting to order at 6:10 p.m.

The Committee first considered this item. Chair Heaphy opening the public hearing. There being no members of the public wishing to speak, the public hearing was closed. Ms. Emmett explained that this lease is the same as the prior lease except with a 2% increase in the rent. The term ends with the end of Representative Himes' term. A motion to approve this resolution was made, seconded and approved by a vote of 6-0-0 (Reps. Heaphy, Nabel, Okun, Ryan, Silver and Zelinsky in favor).

The Committee next considered Item Nos. 5 and 6. Ms. Emmett stated that both items were approved by the Tax Abatement Committee. Mr. Gottlieb explained that this abatement is similar to prior abatements. Charter Oak is renovating a portion of Lawnhill Terrace and the sale to the Limited Partnership is in order to take advantage of Low Income Housing Tax Credits. The prior tax abatement would not apply to the new partnership, although the terms are the same. They expect the current tenants to remain. This is the first phase of the renovation. A motion to approve this ordinance for publication was made, seconded and approved by a vote of 7-0-0 (Reps. Heaphy, Coleman, Nabel, Okun, Ryan, Silver and Zelinsky in favor).

Mr. Gottlieb explained that this project is new construction as a replacement for the Edward Czescik Homes, which were located in a flood plain and suffered damage during Superstorm Sandy. They are using relief funds to build new housing outside of the flood plain, in a location which is better for residents. Since the land is owned by Insprica, Inspirica is a party to the tax abatement. They are hoping that the Czescik property, which is in the Mill River Corridor, will be donated to the City. A motion to approve this ordinance for publication was made, seconded and approved by a vote of 7-0-0 (Reps. Heaphy, Coleman, Nabel, Okun, Ryan, Silver and Zelinsky in favor).

Secondary Committee: Cost Savings & Revenue Enhancement

Chair Heaphy opened the public hearing. Five members of the public, each of whom is associated with a restaurant in the downtown district, and some of whom are Stamford residents, spoke in opposition to this proposed amendment, as did Mr. Ruotolo and Ms. Goldstein, stating that

- restaurants in the downtown area are struggling
- restaurants in other areas of the City have outside cafes
- the restaurant business has a high rate of bankruptcy and turnover
- the DSSD cleans the streets in the downtown area
- this provides an unfair burden on restaurants in the downtown area

There being no other members of the public wishing to speak, the public hearing was closed.

Mr. Hricay noted that this fee has not been increased since 1985 and that Planning & Zoning does plan review and enforcement.

Committee members discussed:

- that this proposal came from the administration
- that the goal was to raise revenue other than increasing homeowner's taxes
- that the purpose of the original ordinance was to permit restaurants in the downtown district to use City streets for outdoor cafes
- that the ordinance is too late for this year
- that many costs are increasing throughout the City and the burden of increase costs should be shared
- whether the increase amount is reasonable

A motion to amend this ordinance to provide that the \$1 per ft.<sup>2</sup> go into effect calendar year 2016 and the \$2 per ft. 2 begin annually thereafter was made, seconded and approved by a vote of 5-4-0 (Reps. Heaphy, Day, Okun, Ryan and Silver in favor; Reps. Coleman, Mitchell, Nabel and Zelinsky opposed).

A motion to amend the ordinance to eliminate the \$100 base fee was made, seconded and failed by a vote of 3-5-0 (Reps. Heaphy, Day and Okun in favor; Reps. Coleman, Mitchell, Nabel, Silver and Zelinsky opposed).

A motion to approve this ordinance, as amended, was made, seconded and failed by a vote of 3-5-0 (Reps. Heaphy, Nabel and Silver in favor; Reps. Coleman, Day, Mitchell, Okun and Zelinsky opposed).

Mr. Tufo explained that KaBOOM! Is a national non-profit that works with corporate donors to build playgrounds. A currently undisclosed corporation will donate the \$85,000 of equipment to KaBOOM! If the City sponsors the initiative. This playground would be built by 125 volunteers in
