## **Committee Report**

The Legislative & Rules Committee met as indicated above. In attendance were Chair Heaphy, and Committee Member Reps. Day, Okun, Nabel, Silver and Zelinsky. Absent or excused were Committee Member Reps. Coleman, Mitchell and Ryan. Also present were Kathy Emmett, Law Department; Clemon Williams, Director of Human Resources; Vikki Cooper, Law Department; Tilford Cobb, Animal Control Authority; Ted Jankowski, Director of Public Safety and Health.

Committee Action

Chair Heaphy called the meeting to order at 7:35 p.m.

Rep. Zelinksy added that he would like the Law Department to look at the amended ordinance and to add the changes that he suggested in order for the Committee and Board to either approve or reject. Without objection, this item was held.

Chair Heaphy outlined changes that were made;

- Comments from Rep. McMullen regarding corrections of wording and clarification of terms
- Recommendations from the American Kennel Club and the Cat Fanciers Association
- Breeding Section changes
  - Breeding Section Reduced to just Dogs
  - \$100.00 yearly permit fee
  - No litter fees
- Mr. Jankowski and Mr. Cobb agreed that the Breeders section will help control abuse
- Rep. McMullen does not agree with the breeding section
- Kennel fee is for up to 10 dogs and opens up to inspection by the State (State law)
- Over 10 dogs requires an application for 2 licenses
- Committee agreed to look over amended ordinance and come back with recommendations at the next committee meeting

Without objection, this item was held.

Mr. Clemons spoke briefly regarding the status of Ethics Training. The committee had several questions regarding whether the training should be available electronically or interactively in person. Other issues discussed:

- Possible creation of a quiz to confirm electronic training
- Ordinance does not say how the training is to be given
- The HR Department is working on the manual which is required by the ordinance
- The HR Department will look into gotomeeting.com (which is an interactive online system)
- The HR Department will get the list of people who have not taken ethics training
- The Committee would like to see the power point presentations
- 250 employees have taken the training

Mr. Madden discussed the attached sheet on Sustainable Strategies. (Highlights-sheet)

- The contract Expires October 2015 with a 2 year option to renew
- Sustainable Strategies work in conjunction with CT's Senators' and Congressman Himes' offices
- Sustainable Strategies hasn't been paid since October 2014 but they have been working for the City
- He will provide the Board office the amount of money Sustainable Strategies has made for the City in 2014-July 2015.

Ms. Cooper explained that the purpose of the changes to these ordinances is for clarity and to be consistent with State statutes that say protected classes are extended to sexual orientation, gender identity and expression. One of the changes has to do with Contractors that do business with the City of Stamford, who are now under the same laws as the City of Stamford with regard to the Social Services Commission (formerly the city's Human Rights Commission.

Ms. Emmett stated this ordinance

- Was at the request of Brian Buckman and Jay Fountain because some nonprofit agencies that provide services to Stamford residents and are appropriated funds from the City have no financial oversight by the city
  - The Law Department, Reps. Buckman and Fountain, and nonprofit agencies that receive money (Library, Nature Center and Volunteer Fire Fighters) met to discuss this issue.
- This ordinance does not apply to nonprofit education agencies.
- Director of Administration is responsible for monitoring outside agencies use of money and has the right to request a financial report
- The attached form agreement can be tweaked depending on the agency.

Rep. Zelinsky made a motion to reduce the \$50,000 to \$20,000; said motion had no second

A motion to approve this item was made, seconded and approved by a vote of 4-0-1. (Heaphy, Nabel, Okun, Silver in favor; Zelinsky abstained)
