Chair Heaphy opened the public hearing on Item LR29.058. There being no members of the public wishing to speak, the public hearings were closed.

Rep. McMullen stated that he would like to include values received by non-profits in addition to funding. Rep. Fountain stated that he was not in favor of this. The purpose of this ordinance is to address agencies receiving over \$50,000 in funding and adding other values would make it too complicated to administer.

Rep. Zelinsky made a motion to decrease the amount in §23-31 from \$50,000 to \$25,000. This motion was not seconded.

Chair Heaphy opened the public hearing on Item No. LR29.060 at 7:17 p.m. Mr. Cacace stated that he was the attorney for Innis Arden Golf Club. He stated that the property being sold was privately owned and encumbered by easements. In 1982, the owner sought to have the easements terminated, but the Court did not terminate the easement owned by Innis Arden, which is for ingress and egress. In 1992, the property was foreclosed upon by the City and is now owned by the City subject to the easement. The City is therefore currently liable for the property and receives no tax income from it. Innis Arden does not want to use the property for ingress or egress, but wants to build a single family home on the lot to house Innis Arden staff.

Innis Arden is willing to include a condition in the agreement that no heavy equipment will be used or stored on the property.

Kevin and Pam Costello spoke requesting more time to voice their concerns over this development. Maria DeMott explained that the property is currently used as a green space by the community in the area. John and Audrey Iscaro expressed concerns that the property will be used for 30 or 40 people. Jose Mujica stated that there is a great sense of community and there is already a connection to Fairfield Ave. Chris Nizolek expressed concerns about Innis Arden as a neighbor, noting that they had put up plastic fencing and neglected the maintenance of the border. Althea Brown stated that there needed to be green space in the neighborhood. Geogeann Vitti Saint expressed concerns that the property backs onto other homes and the number of people living there and whether it will be used as a storage area. Elizabeth Kumak expressed concern that the people living there will be transients.

There being no further members of the public wishing to speak, Chair Heaphy closed the public hearing at 7:40 p.m.

Committee members discussed with Mr. Toma and Mr. Pollard (and Mr. Cacace upon the request of Mr. Toma and Mr. Pollard) that:

- the City received an appraisal of the property on May 1, 2015, concluding that the property would be worth \$220,000 if it were unencumbered but the easement reduces its value to the City of Stamford to \$110,000
- the parcel is not subdivided and is zoned for a residence for 1 family or 4 unrelated people
- The intent is not to remove the wooded area, but to put the house near the street
- The agreement is currently silent as to heavy equipment; Innis Arden would be glad to incorporate restrictions regarding heavy equipment in the agreement
- If a child is injured on the property, the City could be liable
- The easement is a permanent easement for ingress and egress of vehicles and pedestrians
- The City can't turn the property into a park, because of the easement

Committee members discussed various changes to the draft ordinance, including changes to make the language and format consistent. A motion to strike the 6th Whereas Clause was made, seconded and failed by a vote of 2-6-0 (Reps. Ryan and Zelinsky in favor; Reps. Heaphy, Coleman, Day, Mitchell, Okun and Silver opposed). The review covered Sections 111-1 through 111-6. Changes discussed included:

- changing the phrases owner, keeper or custodian to owner/keeper throughout
- clarifying that Sec.111-4.B should apply to animals on leashes
- Changing Dog Warden to Animal Control Officer
- Clarifying that Sec. 111-6.B. applies only to dogs
- Eliminating titles in subsections
- Changing dangerous dogs to dangerous/vicious dogs
- Clarifying that Property of another does not include the property of a dog owner/keeper.

A motion to hold the item to continue the review of the remaining sections was made, seconded and approved by unanimous vote (Reps. Heaphy, Coleman, Day, Mitchell, Okun, Ryan, Silver and Zelinsky in favor).
