## **Committee Report**

## Secondary Committee: Parks & Recreation

Chair Heaphy opened the public hearing. There being no members of the public wishing to speak, the public hearing was closed.

Mr. Rosenberg stated that the State is conveying Cubeta Stadium to the City, per a State Special Act. The property had been conveyed to the State in 1954. The City has been using and maintaining the stadium. The only change is the change in ownership. There are anticipated to be \$1500 in administrative costs in connection with the transfer, but no other costs beyond the costs already expended by the City and any cost of including the property in the City's insurance rolls.

A motion to approve this resolution was made, seconded and approved by a vote of 6-0-0 (Reps. Heaphy, Coleman, Mitchell, Nabel, Okun and Silver in favor).

2. <u>LR29.093</u> RESOLUTION <u>and public hearing</u>; Approving a Lease between Our Lady Star of the Sea Corporation and the City of Stamford for 1170 Shippan Avenue, Stamford, CT.

Chair Heaphy opened the public hearing. There being no members of the public wishing to speak, the public hearing was closed.

Mr. Rosenberg explained that the school has been closed, and the building is empty. This presents an opportunity to run the programs listed on Exhibit B. The lease is for 4 years and consists of 11,000 ft<sup>2</sup>.

Ms. Albano explained that this will provide a home for the daytime recreation programs. Cleaning and maintenance expenses were included in the budget. The programming will hopefully start in December.

 <u>LR29.091</u> REVIEW; Possible Ordinance Restricting Single-Use Report Made Plastic Shopping Bags. 09/15/17 – Submitted by Rep. Heaphy

Chair Heaphy explained that there are currently plastic bag bans in Westport, California, Austin, TX and an entire nation, Kenya. Westport is the only town in CT with a plastic bag ban, but there are other cities which have imposed one. The concern is that plastic bags get into the food chain. Committee members noted they would like to hear from Mr. Madden and members of the business community about this possibility.

4. <u>LR29.094</u> REVIEW; Annual Report of Animal Control Officer of Activities, Practices and Policies of Stamford Animal Control and Care Center as required by <u>Code §111-10.F</u>.

Mr. Jankowski and Mr. Cobb reviewed the <u>attached report</u>. Feral cats continue to present a problem, particularly since the State stopped giving out spay/neuter vouchers. The existing site has been cleaned and painted. Illegal breeding has not been a problem. Nobody has sought a breeder's license because that has not been publicized yet.

Ms. Collucci and Ms. Girardi noted that they have received requests for help with medical costs and spaying/neutering.
