Also present were Reps. de la Cruz; Figueroa, Mays, Morson, Stella, and Tomas; Sandra Dennies, Director of Administration; and Chris Dellaselva and Dana Lee, Office of Corporation Counsel.

Co-Chair Berns opened the public hearing. Kieran Edmondson spoke in support of selling 384 Elm Street. There being no further speakers, the public hearing was closed.

Ms. Dennies explained that the Board approved this sale at the July meeting with the condisiton of no zoning changes. The property had been acquired with FTA funds and must be sold under FTA rules. 80% of the sale price will go back to the FTA. The appraisal of the property set the minimum bid as \$860,000. The maximum offer of \$1,275,000 was received from 336-352 Elm Street, LLC, and the property was awarded pursuant to Code §9-5.

Mr. Dellaselva explained that this is an "as is" sale with no contingencies in the agreement. If it is approved by the Board, the closing will take place within 30 days of execution of the agreement by quit claim deed.

Committee members discussed Item No. 1 with the invited guests. Items discussed included the following:

- The purchasers are the adjacent property owners
- 8 individuals looked at the property and 2 bids were received

A motion to approve Item No. 1 was made, seconded, and approved by unanimous voice vote (Reps. Berns, Nabel, Boeger, Cottrell, Miller, and Sherwood in favor).

Co-Chair Berns opened the public hearing. Kieran Edmondson spoke in support of selling 402 Elm Street. There being no further speakers, the public hearing was closed.

Ms. Dennies explained that the Board approved the sale of this parcel at the July meeting. The property had been acquired with FTA funds and must be sold under FTA rules. 80% of the sale price will go back to the FTA. The appraisal of the property was \$120,000. The only bid received was for \$151,000. Because the property is ineligible for curb cuts, it is only attractive to abutting property owners.

Mr. Dellaselva explained that this is an "as is" sale with no contingencies in the agreement. If it is approved by the Board, the closing will take place within 30 days of execution of the agreement by quit claim deed.

A motion to approve Item No. 2 was made, seconded, and approved by unanimous voice vote (Reps. Berns, Nabel, Boeger, Cottrell, Miller, and Sherwood in favor).

Mr. Lee explained that this proposed ordinance restricts the use of gas-powered leaf blowers to 8 a.m. to 6 p.m. Monday through Friday and 10 a.m. to 3 p.m. on Saturdays, Sundays and Holidays. City employees are exempted from this provision because of the hours during which employees do leaf collection. The proposal also increases the fine for violation of the ordinance to \$250/hour. This will address situations in which the fine just becomes a cost of doing business and will encourage businesses with outdoor entertainment to self-regulate.

Committee members discussed the proposed ordinance. Items discussed included the following:

- Noise is often fleeting and the ordinance is difficult to enforce,
- Inspectors can get to the site for outdoor entertainment; after an initial warning, violators would get a citation
- This year, outdoor dining permits are conditional upon compliance with the noise ordinance
- The ordinance is enforced by the health department and the civil citation officers
- How would residents who work during these hours clean up their leaves?
- Electric blowers make less noise
- Why is the city allowed to do something which residents are prohibited from doing?
- Sound isn't amplified by traveling over water, but doesn't dissipate; the ordinance should address measuring sound across the water

- This is better than the current ordinance
- Enforcement is an issue

A motion to amend the whereas clauses to include the following language was made and seconded:

WHEREAS, leaf blowers in general, and especially larger ones, blow an inordinate amount of dust into the air to the detriment of the health of the public;

WHEREAS, small gas powered engines, and especially two-stroke gas powered engines, spew a much greater amount of pollution than other and larger gas powered engines;

After extensive discussion regarding the purpose of Whereas clauses (to explain legislative intent), the motion and second were withdrawn.

A motion to hold Item No. 3 was made, seconded, and approved by unanimous voice vote (Reps. Berns, Nabel, Boeger, Cottrell, Miller, and Sherwood in favor).

Chair, in the case of committee meetings). However, any additional appointed Parliamentarian may advise on the proper procedure if requested.

A motion to approve Item No. 5 was made, seconded, and approved by unanimous voice vote (Reps. Berns, Nabel, Boeger, Cottrell, Miller, and Sherwood in favor).
