Committee Meeting and Public Hearing Minutes

Date: Tuesday, June 23, 2026

Time: 7:00 p.m.

The Legislative & Rules Committee met as indicated above. Present were: Chair McKeown, Vice Chair Camporeale, and Committee member Reps. Blank, Boudreau, Hughes, Hyatt, Lapine, Stone, and Weinberg. Also present were ex-officio Reps. Morson and Walston; City staff Lauren Meyer, Mayor’s Office, as well as members of the public.

Chair McKeown called the meeting to order at 7:01 p.m.

Chair McKeown then called for a motion to suspend the rules to (i) hold the public hearing with respect to each of LR32.016 and :R32.017 consecutively, and thereafter (ii) to consider LR32.017 before LR32.016. The motion was made, seconded, and approved via a unanimous voice vote of 9-0-0 (Chair McKeown, Vice Chair Camporeale, and Committee Reps. Blank, Boudreau, Hughes, Hyatt, Lapine, Stone and Weinberg approved).

Blank, Boudreau, Hughes, Hyatt, Lapine, Stone and Weinberg approved).

Chair McKeown then called for a vote for the motion to approve LR32.017 as amended for a second public hearing. This motion was made, seconded, and approved via a roll call vote of 8-1-0 (Chair McKeown, Vice Chair Camporeale, and Committee Reps. Blank, Boudreau, Hughes, Hyatt, Lapine, and Stone approved; Rep. Weinberg voted against).

Chair McKeown called for a motion to adjourn and adjourned the meeting at 7:39 p.m.
