**PROPOSED RESOLUTION NO. _____
CONCERNING BUILDING PERMIT FEES AND
CERTIFICATE OF OCCUPANCY FEES**

NOW, THEREFORE, BE IT RESOLVED, that pursuant to and within the limitations of Sec 123 of the Code of Ordinances, the Board of Representatives hereby approves the following building permit fees schedule:

Category Fees

Building Permits-Commercial

Sixteen and 50/100 dollars (\$16.50) per each one thousand dollars (\$1,000) of estimated cost or fraction thereof for the first one million dollars (\$1,000,000) of estimated cost and twenty-five dollars (\$25.00) per each one thousand dollars (\$1,000) of estimated cost or fraction thereof above one million dollars (\$1,000,000) of estimated cost per permit

Building Permits-Residential

Thirteen dollars (\$13.00) per each one thousand dollars (\$1,000) of estimated cost or fraction thereof per permit

For all permits listed above, the fee shall not be less than:

Sixty dollars (\$60.00) for Building Permits-Residential

Seventy-Five dollars (\$75.00) for Building Permits-Commercial

BE IT FURTHER RESOLVED that this schedule shall take effect on January 1, 2019, or the 1st of the next month at least 30 days after enactment, whichever is later.

**SUMMARY OF PROPOSED ORDINANCE NO. _____ SUPPLEMENTAL
AMENDING CHAPTER 137, ARTICLES I, II, and IV CONCERNING TIPPING FEES
FOR MUNICIPAL WASTE AND RECYCLABLE MATERIALS**

This ordinance amends Chapter 137, Articles I, II and IV to 1) eliminate the requirement for a dumping license; 2) change the tipping fee for dumping waste materials to the cost of disposing or hauling away such material, which may vary depending upon the nature of the material, plus an amount up to \$25.00 per ton; 3) impose a separate fee for recyclables of the cost of disposing or hauling away any material, which may vary depending upon the nature of the material, plus an amount up to \$15.00 per ton; 4) permit an individual who resides within Stamford or owns a residential property in the City to dispose of up to 200 pounds of waste material generated at such residence or residential property without incurring a tipping charge; 5) permit an individual who resides within Stamford or owns a residential property in the City to dispose of up to 200 pounds of recyclable material generated at such residence or residential property without incurring a tipping charge; 6) increase the fine for violation of the article to \$100.00; and 7) provide procedures for the revocation of dumping privileges by the Director of Operations.
