RESOLUTION NO. 4403 AMENDING CITY OF STAMFORD PARKS AND RECREATION COMMISSION REGULATIONS SET BY RESOLUTION 3889 AND AMENDED BY RESOLUTIONS 4287 AND 4376

WHEREAS, in accordance with the provisions of Section 175-1 of the Stamford Municipal Code of Ordinances, the Parks and Recreation Commission of the City of Stamford has promulgated rules and regulations for the health, welfare and safety of the community; and

WHEREAS, said rules and regulations are necessary for the proper safety, maintenance, security, and efficient operation of Stamford's Parks and Recreation Facilities; and

WHEREAS, the current Rules and Regulations were adopted by the Parks and Recreation Commission of the City of Stamford on December 20, 2017 and modified on January 16, 2018 by the Board of Representatives by Resolution No. 3889 on April, 2, 2018 Regular board Meeting and modified by the Parks and Recreation Commission of the City of Stamford on May 15, 2024 and approved by the Board of Representatives on July 8, 2024, by Resolution No. 4287 and approved by the Board of Representatives on May 15, 2025 by Resolution No. 4376; and

WHEREAS, the following proposed amendments to the Rules and Regulations on were adopted by the Parks and Recreation Commission of the City of Stamford on September 17th, 2025 and approved by the Board of Representatives at its regular meeting on Wednesday, November 5th, 2025.

NOW, THEREFORE, BE IT RESOLVED that the regulations adopted pursuant to Board of Representatives Resolution 4287 are hereby amended as follows and shall apply to all Parks and Recreation Facilities in the City of Stamford.

Section 175-1-17: Wildlife

- a) No person, other than a City of Stamford employee, agent or contractor engaged in a humane wildlife control program authorized by the Parks and Recreation Commission, shall intentionally or recklessly harass any wild bird or animal within the limits of any park or recreational facility.
- b) No person, other than a City of Stamford employee, agent or contractor acting within the scope of their duties, shall give, place, expose, deposit, distribute or scatter any edible material within the limits of any park or recreational facility with the intention of feeding, attracting, or enticing waterfowl.

c) Any person who violates any provision of this section shall be guilty of a Level 2 violation of these Regulations.

This resolution shall take effect upon its enactment.
