## **Committee Report**

The Parks & Recreation Committee met as indicated above. In attendance were Co-Chair Caterbone and Committee Member Reps. de la Cruz, Giordano, Heaphy, Hoch; Pratt and Ryan. Absent or excused were Committee Member Reps. Franzetti, Mahoney, McGarry and Wallace: Also present were Erin McKenna, Land Use Bureau; Jeff Olszewski, Stantec; and Laurie Albano, Recreation.

Co-Chair Caterbone called the meeting to order at 5:35 p.m.

 1. PR29.038
 REVIEW; Status of implementation of Cummings Park Master Plan improvements. (at 5:30 pm) 11/10/16 – Submitted by Rep. Ryan
 Report Made

Ms. McKenna explained that the City did a master plan for the park in 2015, but funds have been scarce, so only changes to the pavilion can be made at this time. Mr. Olszewski and Ms. McKenna reviewed the proposed changes with the Committee:

- They are at about 60% completion of the construction documents and expect to submit bid documents in April
- They can do work up to 50% of the appraised value of the pavilion
- There will be a total facelift to the pavilion, including ADA compliance for the bathrooms, repurposing of the changing areas and opening the area up visually
- They are on schedule and on budget
- They have \$356,000 to spend, they will also be demolishing the concession stand. The concessionaire will be using food trucks. The City is negotiating with him regarding the idling of his trucks
- The department asked for more money in the Capital Budget, which was already cut by the Planning Board
- The footprint of the pavilion won't change
- It will be more flood proof
- Any hardscape changes will be incorporated into the final design

- The contract is for redesign and reconstruction of the entire waterfront and includes combining the fields into one lighted field.
- The goal is to do this pavilion work after Labor Day

Co-Chair Caterbone opened the public hearing. There being no members of the public present wishing to speak, the public hearing was closed. Ms. Albano explained that this is a cost recovery fee because they are expanding the hours of the camp by one hour in response to parent requests. The cost will be \$200 for a two week session.
