²Mr. Pollard spoke briefly regarding this item and talked about the challenges fiscally that the City has is being discussed at this time in Executive Session with the Board of Representatives Fiscal Committee and the Mayor. He said the Mayor is open to budget increase for parks police but there are barriers. The Mayor has done a lot to increase public safety for the City of Stamford and has the highest amount of officers in the City

Mr. Knott spoke briefly on this item. He said since the last meeting a lot of work has been done.
