Co-Chair Mahoney called the meeting to order at 6:35 p.m. A motion to take PR30.034 was made, seconded and approved unanimously.

Committee discussed the following:

- Confirmed this ordinance can be enforced with effort
- Life Guards can call police but cannot enforce
- Civil Citation officers have no police authority; Officer Gould does not agree with civil citations officers enforcing the ban

- Some members in favor of smoking areas
- Discussed medical marijuana users being harassed; confirmed medical marijuana users are not allowed to smoke in public areas
- An infraction, under this ordinance, must be witnessed by the officer
- First offense would be a written warning
- No ban for golf courses seems unjust
- Committee agrees to hear from the public

After a lengthy discussion a motion to approve this item for publication was made, seconded and failed by a vote of 3-5-0. (Giordano, Pratt and Stella in favor; Mahoney, Matherne, Saftic, Wallace and Watkins opposed)

2. PR30.037 REVIEW; Update on Lione Park Bathrooms. **Report Made** 10/08/19 – Submitted by Reps. Stella and Pratt

Committee Discussed:

- There's only one urinal and one toilet in men bathroom; been working for 2 years on ways to resolve this problem
- Complaints from neighbors and people using the park of the uncleanliness
- Project was put on hold because of cost
- Lou Casolo was asked by many people to develop a resolution to this issue
 - Provided different layouts to the Director of Operations
 - Director of operations picked a layout but it does not include expansion of building
 - Developed a cost estimate from the layout chosen (just a concept plan)
 - Once the cost estimate was received, confirmation was received to proceed with this design.
 - Contacted architect that the City has used that designed bathrooms at Scalzi Park
 - Once received the final design cost proposal, it exceeded the threshold for the purchasing ordinance
 - Mr. Casolo had to get 2 other quotes from architects for this job
 - Once received, returned to lowest bidder and is now going through the regular process and moving forward
 - Funding is in place
 - The construction document that will be in for bid will be finished in a few weeks
 - Contract award will be in February 2020
 - Construction may take 4 months; Early summer should be completed
 - Existing facilities 3 toilets for women; 1 urinal and 1 toilet for men
 - Proposed; 2 toilets 5 urinals for men; 4 toilets for women
 - Confirmed lighting will be increased

Co-Chair Mahoney adjourned the meeting at 8:30 p.m.
