SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL AMENDING CHAPTER 40 OF THE CODE OF ORDINANCES, TO ADD ARTICLE LIII, SECTIONS 40-184 THROUGH 40-197- DEPUTY DIRECTOR OF OPERATIONS FOR INTERDEPARTMENTAL AFFAIRS

This proposed ordinance adds a new article to Chapter 40, Officers and Employees, of the Code of Ordinances to create the position of Deputy Director of Operations for Interdepartmental Affairs to coordinate operations more ably among divisions within the Department of Operations; strengthen cross-Department collaboration; and implement integrated policies, procedures, and practices Department wide.
