Mr. Williams and Ms. Emmett noted that:

- Mr. Robles has been a captain with SFD since 1997, with an impeccable career, and numerous certifications
- He set up the first computer network in the SFD and managed the radio upgrade and 2 CAD implementations
- He is an important addition to the administration of the Fire Department
- The contract is modeled on Chief Roach's contract,
- It is for 4 years with a 1 year renewal option
- He has been employed as an Acting Chief since February at the 3rd step in grade 5, which matches Assistant Chief Morris' pay and was approved by the Personnel Commission (effective July 1, he will be at Step 4)
- If he leaves the position prior to the end of the 4 year term, he only receives his pension at the captain level (unless the City terminates the contract)

- This position is the Assistant Chief over the paid firefighters; this position was created as part of the consolidation
- The two Assistant Chiefs work collaboratively

Mr. Williams will send the signed vehicle policy to the office prior to the Board meeting.

Mr. Williams and Ms. Emmett stated that:

- His department has been sending things out about the policy and cover it in orientation
- They have not been asking people to sign the policy until after they are hired; going forward it will be included in the employment application itself
- The ordinance specifies that an employee may not work directly for a relative
- They have had no problems with lack of disclosure or supervision by relatives
- The Board of Education is not subject to the policy
- They also check for family relations when there is a promotion; so far they have been able to work this out with the unions
- The only instance of reporting to a relative was in the Highways Department, which was disclosed and worked around
