Pre-operational Group Daycare Center Plan Review and Inspection Fee (7 to 12 children)	\$125.00

**SUMMARY OF PROPOSED ORDINANCE
AMENDING CHAPTER § 141-3
OF THE CODE OF ORDINANCES, HAIRDRESSERS AND
COSMETICIANS, SECTION 141-3 - PLAN REVIEW AND
PREOPERATION INSPECTION**

This ordinance amends Section 141-3 of the Code of Ordinances to permit the imposition of fees for pre-operational inspections by the Director of Health in connection relocation, construction, remodeling or extensive alteration of a barbershop or hairdressing and/or cosmetology shop and permits the fees to be set by Resolution of the Board of Representatives.
