SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL AMENDING CHAPTER 146, SECTION 13 OF THE CODE OF ORDINANCES CONCERNING THE SETTING OF A FINE THAT MAY BE IMPOSED BY THE HEALTH DEPARTMENT FOR VIOLATION OF CHAPTER 146 OF THE CODE OF ORDINANCES

This proposed ordinance amends Chapter 146 of the Code of Ordinances, Housing Standards, Section 146-13, to provide for a fine of \$250.00 per day to be levied by the Health Department under the civil citation process for violation of the City of Stamford's housing standards, set forth in Chapter 146.

SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL AMENDING CHAPTER 146, SECTION 34 OF THE CODE OF ORDINANCES CONCERNING THE SETTING OF A FINE FOR THE LATE SUBMISSION OF A RENEWAL APPLICATION FOR A MULTI-FAMILY DWELLING OPERATING LICENSE

This proposed ordinance amends Chapter 146 of the Code of Ordinances, Housing Standards, Section 146-34, to provide for a fine of \$250.00 for failure to file a renewal application for a multi-family dwelling operating license within 60 days prior to the expiration of the present operating license and providing that violators shall be liable for the full annual amount of a license in order to obtain a renewal license.
