Committee Minutes

Date:Thursday, August 26, 2021Time:6:30 p.m.Place:This meeting was held remotely.

The Public Safety & Health Committee met as indicated above. In attendance were Chair Stella, Vice Chair Morson and Committee Member Reps. Curtis, Matherne, McMullen, Palomba, Sandford and Sherwood. Rep. Giordano was excused. Also present were Reps. Adams, and de la Cruz; Ted Jankowski, Director of Public Safety, Health & Welfare; Cynthia Anger and Dana Lee, Law Department; Tyler Theder, Operations; James Ritchie, NRA Instructor; and Trevor Roach, Fire Chief.

Chair Stella called the meeting to order at 6:34 p.m.

James Ritchie, NRA instructor, stated that this is a fourth amendment issue. There are currently 9 open court cases fighting against providing gun permits to law enforcement. Recently in the State of Connecticut, there's a new case with the same claim. Many believe this is a public safety issue, but nowhere in the Constitution, can you deny someone their constitutional right to open carry. If a person is carrying a gun, it is not considered to be reasonable suspicion of a crime. Stamford has 23,000 registered gun owners. This bill has been bought up in the state and has been turned because it is unconstitutional. Other possible solutions to stop gun violence is education.

The Committee discussed the following:

- Concerns with illegal gun owners and underage use of guns
- No law is being passed just resolution to encourage a bill to be passed in support of this item
- Would like the State to look into this item in more debt because there are valid points to be made on both sides of the argument

- State law allows for open carry for persons with permits.
- State law prevents officers from asking to show proof of a license unless they have a reasonable suspicion of a crime.
- Most requests for showing a gun license originate from a phone call from a member of the public. However the phone call is not enough, the officer must have suspicion of a crime.
- This has previously failed in the State Legislature due to numerous concerns including racial profiling, and 2nd Amendment and 4th Amendment rights.

Rep. McMullen encourages his colleges to vote against this item because he feels it would be wasting State representatives time since this bill has been turned down several times previously by the State.

A motion to approve Item #1 was made, seconded and approved by a vote of 6-1-1 (Reps. Morson, Stella, Curtis, Matherne, Palomba, and Sandford in favor; Rep. McMullen opposed; Rep. Sherwood abstaining).

Mr. Jankowski and Fire Chief Roach discussed the following with the Committee:

- In the process of formerly defining what we're considering Critical Information dispatch
- In the past they put up information related to certain hazardous or dangerous conditions right into the CAD system and as units responded, they were able to get that message
- Some things have slowed down because of the pandemic
- 911 communications director has been put in charge of relaying any critical information points or any hazardous conditions that first responders need to be made aware of
- Truss construction can be the worst nightmare for first responders when they're coming into a fiery situation, it has a tendency to collapse quickly
- Working with our buildings department to identify and make available for part of the critical information dispatch.
- Every building encountered are considered as being truss construction
- IPads will be put into all rigs to see possible critical dispatch information
- Pushing towards a new records management system; current one is outdated

- Tax payers money was spent in court in order to get this company to comply with regulations
- The Administration needs to invest to surveil this company to rectify this situation
- Considering a Resolution to the Administration and City departments to work actively to resolve this situation

Ted Jankowski discussed the following:

- There are different types of indoor air quality monitoring that's been going on for many years
- Operations perform air monitoring at the old Police Station and Marina at Cummings Park
- Working with DEEP on the south end outdoor air monitoring with contractors
- Petitioned for DEEP to supply an air monitoring station in Stamford and it was not available
- Working with a JJ Wilbur Company regarding outside air monitoring; supplied estimates for recommended air sensor systems
- The system they are seriously considering and recommended is called a Purple Air PM 2.5 Air Quality Sensor (New Haven uses this system)
- Next step is to work with DEEP to get approval for air censors
- Once approved they will contract with the JJ Wilbur Company for installation
