Chair Stella explained that he submitted this item because he attended a fire training and this issue continued to be raised.

rates down. They have policies and procedures to follow to encourage a safe environment. If PFAS free protective gear becomes available they agree to switch and the cost would be around \$1.5 million. President Anderson, from the local 786 let Chief Roach know that they are expecting PFAS free equipment within that the next 5 to 6 years.

Rep Berns suggests the Board communicate to the Mayor and her Administration to look into alternative protective clothing for our firefighters and alternatives to any other sources or internal sources that are purchased and/or maintained by the department that may have PFAS.

A motion to hold this item was made seconded and approved by a vote of 6-0-0. (Reps. Stella, Morson, Berns, Campbell, Garst and Pavia in favor)

2. PS31.031 REVIEW: Supervisory Coverage at the 911 Dispatch Center during Midnight and Weekend Shifts as a result of Civilian Grievance.

Director DeRubeis and Chief Shaw discussed the following:

- Questions and concerns were raised regarding this subject and a plan has been put in place
- At no time did they fill there was a safety issue for the City
- A reasonable solution has been made that won't compromise the safety of our first responders or citizens
- Supervisory coverage was negotiated in the Police Union Contract years ago
- Unfortunate reallocation of resources came up and had to be addressed (supervisors needed in other areas)
- There will be 21 shifts a week (3 daily)
- Sergeant in the main building for 10 shifts and Civilian dispatch for others
- Regarding the Civilian grievance; it was discussed with Human Resources and the police union

Chair Stella adjourned the meeting at 8:16 p.m.
