The Public Safety & Health Committee will meet as indicated above. In attendance were Chair Stella, Vice Chair Morson, and Committee Member Reps. Phil Berns, Campbell, Camporeale, Graham, Pavia, and Pollack. Also in attendance were Rep. Adams, de la Cruz, and Walston; Lou DeRubeis, Director of Public Safety; Jody Bishop-Pullan, Director of Health & Human Services; Cynthia Anger, Corporate Counsel; Dipika Khushalani, Manager of Public Health Programs; Ralph Blessing, Land Use Bureau Chief, and Anita Carpenter, Grants Officer. Absent or excused was Rep. Roqueta.

Chair Stella called the meeting to order at 6:31 p.m.

Director DeRubeis stated that A. Vitti Construction is a private business that established its operating systems in accordance with all the regulatory and state statutes. Chair Stella countered that, as documented by the video evidence provided showing rock crushing operations with the building doors wide open, Vitti Construction was not complying with the settlement agreement established in Superior court. Chair Stella asked what was the Administration going to do to make Vitti comply, such as sending citation officers to investigate and issue citations. Representative de la Cruz added that the citations would provide documentation to support any further action enforcement action the Administration may have to take.

Director Bishop-Pullan advised that if the air quality issue is due to fugitive dust and complaints are received:

- An inspector can be sent to investigate.
- DEEP (Department of Energy & Environmental Protection) can then continue the investigation.

Representative de la Cruz asked if the inspectors could be sent in real time. Director Bishop-Pullan replied yes, most of the time. Representative de la Cruz added that the inspector reports would provide documentation to support any further action enforcement action the Administration may have to take.

Given that further discussion is needed of the Administration plans to deal with this problem, a motion to recommit Item 1 was made, seconded, and approved by a vote of 8-0-0 (Chair Stella and Vice-Chair Morson, Reps. Phil Berns, Campbell, Camporeale, Graham, Pavia, and Pollack in favor).

Representative de la Cruz stated that many of our ordinances are not complied with, primarily because business entities and residents are unaware of them, such as the ordinances banning plastic bags and Styrofoam containers. He recommended that the Administration implement an informational campaign through the mail, social and print media, etc. to inform the public and businesses of the existence of ordinances that affect their operations.

Representative Phil Berns requested a breakdown from Director DeRubeis of the number of complaints by residents regarding the use of plastic bags that have been banned pursuant to the City ordinances.

Given that further discussion is needed of the Administration plans to deal with this problem a motion to hold Item 2 was made, seconded, and approved by a vote of 6-0-1 (Vice-Chair Morson, Reps. Phil Berns, Camporeale, Graham, Pavia, and Pollack in favor, Rep. Campbell abstained).

REVIEW; grant approved by the Board of Representatives one year ago for the geo spatial air pollution truck (GMAP) approved for the South and West end of Stamford where the life expectancy (according to a Stamford Hospital study) is eight years less than that of a north Stamford resident. The same disparity in health is found in asthma rates from the North to South sides. The air monitors that are currently in place only monitor particles. The trucks cover toxins, gasses, and pollutants other than just particles.

Director Bishop-Pullan provided updates on the air quality monitoring research in Stamford's South End and West Side neighborhoods.

- The EPA (Environmental Protection Agency) awarded a grant of \$68,755.
- The project duration is from November 1, 2024, to October 31, 2025.
- The goal of the initiative is to build a capacity of community residents to measure air pollutants in real-time and educate residents to make data informed life-style choices.
- Air quality monitors:
 - o There are three Aeroqual AQY-R air quality monitors.
 - Continuous measurements of O3 (ozone), NO2 (nitrogen dioxide), and PM2.5 (particulate matter 2.5) will be collected and averaged in our intervals.
 - The stationary locations are to be determined.
 - An online air quality dashboard will allow the public to interface with the air sensor data.
 - The website will give real-time information and will be user-friendly.
- A community meeting is planned for the week of November 18, 2024.

Chair Stella and Representatives de la Cruz and Adams stated that, unlike the current purple air monitors, these monitors need to be placed where the pollution occurs, not far away and 20+ feet up in the air. Vice Chair Morson stated that only three monitors was not sufficient for the large areas to be covered.
