Rep. Camporeale explained she spoke to a few homeless people in New York City who would not to go to warming centers they did not want to leave their pets. She wants to know what is Stamford's policy on animals in warming centers.

Director DeRubeis spoke to Tilford Cobb, the animal shelter coordinator, and there is no specific policy. They do take abandoned animals and will take temporary surrendship of a pet in an emergency, such as hospitalization of the owner. This is on a case by case basis but the animal shelter is not set up to take an influx of animals during cold weather.

Director Bishop-Pullan said the shelter system in Stamford is run through the State's 211 system. The starting point would be to connect with the 211 system about the shelters. Stamford's daytime warming centers are either municipal buildings or community partner buildings and only allow service animals. Overnight warming centers are the shelters.

Rep. Campbell stated there are some warming centers and emergency shelters in Bridgeport, Enfield, and Vernon that take animals. It would be a good idea to talk to the people who run these.

Chair Stella stated that as a city we can do better with this as no one should be turned away from seeking shelter because they have a pet.

Rep. Camporeale explained she received a letter from a hunter asking to use her property because there are several apps that tell hunters properties for potential use. Her property is less than one acre and was surprised that people can hunt on land that size.

Sergeant Booth said there is no city ordinance that controls hunting, it is all under state law. Hunting is allowed on private property with the owner's written permission. While all firearms can only be discharged a minimum of 500 feet from a human dwelling or a barn with domesticated animals, centerfire rifles can only be used on a minimum of 10 acres that is a single piece of property.

The 10 acre minimum only covers centerfire rifles, which is the standard for hunting. There are no minimum acreage laws for other types of guns and for bow hunting.

Westport has a stricter law than the state, but it is allowed because it existed before the Charter.

Chair Stella stated it is concerning that there are no acreage laws regarding bow hunting. While there are professional hunters, there could be non-hunters playing with a bow and arrow and a person could get struck. Additionally, it is the responsibility of a hunter to pursue a target if that target is struck but does not come down. If this does not happen, it can be very disturbing for people to witness a deer walking around with an arrow in it. He agrees that more research and conversation needs to happen regarding this topic.
