- The beginning of every session multiple Bills gets proposed; upward of 5000.

• Committees: Chair of the Government Administration & Elections Committee and Judiciary Committee

### Representative Caroline Simmons:

- Committees: Higher Education Committee; The Public Safety Committee and Chair of the Commerce Committee
  - Some priorities and initiatives; work force development initiative for unfilled jobs in Connecticut including around 15,000 manufacturing jobs; better resources for Guidance Counselors in Schools; Better Training programs at Technical High Schools and Community Colleges; make it easier to start or grow businesses by digitizing resources; Opportunity zones passed by the Federal Government for incentives for governments in distress and Connecticut is trying to match that program; Better marketing the State for businesses to move here, specifically Fairfield County

# Representatives Matthew Blumenthal:

- Committees: Vice Chair, Judiciary Committee; Education Committee; and Government Administration & Elections Committee
  - Priorities: Gun Violence prevention bills; Ghost Guns; Safe Storage Guns; Marijuana Legalization; Criminal Justice Reform; Fixes to the Trust Act, to insure law enforcement is focused on dangerous individuals and better relationship with the community; Mold problems in Stamford Schools bills; Train Station Modernization; Fairfield Five bills

## The Committee discussed the following with State Legislators:

- The Regionalization that's occurring in the State regarding Education will not affect Stamford; this bill was put forward to start a conversation, on the campaign trail it was said they need structural reform in Connecticut to get back on track to save money and creation of efficiencies; hearing out ideas and to have discussions in a public forum
- Regarding Legalization of marijuana the conversation has moved to how should we
  do this the right way:
  - Looking into: Penalties; criminal justice (prior marijuana convictions);
     regulations; people driving high; medical program; equity;
  - Different committees will look into program from different point of views (Public Health, General Law, Finance and Judiciary)
- Legislators agreed with the local plastic bag initiatives; Governor agrees with a bill regarding plastic bags
- Gun Control legislation will be discussed early March
- Each Session you have to propose Bills as new; bills from last session have to be reintroduced
- Teacher's Pension funding being pushed towards the Municipalities
- State wide car tax is on hold
- Formation stage of Mold situation in Stamford; either appropriated money or making it
  easier for Stamford to get existing money; Mold issue is State wide; Historically mold
  issues are usually a local issue; working diligently to come up with a plan to resolve
  this problem
- Stamford train station needs a new garage to continue to thrive and grow; 100 million dollar figure for Train station modernization; then address old deteriorated garage
- TIF District legislation has been passed; The City has a say to utilize it or not
- Tolls Bill
  - Would like public debate
  - Money would help State financial situation
  - Exemptions (law enforcements; emergency personnel)
  - o CT residents discounts
  - o EZ Pass
