**SUMMARY OF PROPOSED ORDINANCE**  
**PROHIBITING WASTES GENERATED FROM**  
**OIL & GAS DRILLING AND EXTRACTION ACTIVITIES**

This ordinance prohibits 1) the application of any natural gas waste or oil waste on any road or real property located within the City of Stamford; 2) the introduction of any such waste into any wastewater treatment facility within or operated by the City of Stamford; 3) the introduction of any such waste into any solid waste management facility within or operated by the City of Stamford; and 4) the storage, disposal, sale, transfer, handling or processing of such waste within the City of Stamford.

The ordinance further requires 1) all bids and contracts for services for any publicly owned or maintained road or real property within the City to contain a provision stating that no such waste shall be used in providing the services; 2) all bids and contracts for the acquisition of materials to be used for the construction or maintenance of roads or real property within the City state that no materials containing such waste will be provided to the City; and 3) all bids in connection with the retention of services or the purchase of materials to be used for the construction or maintenance of roads or real property within the City state that no such waste will be used by the bidder or any contractor or subcontractor thereof in connection with the bid.

The ordinance provides penalties for violation thereof, including, but not limited to, remediation, recovery of costs and attorneys' fees and a fine of \$250 per day.

This ordinance shall take effect upon enactment.
